Moved by Tobias, seconded by Wood that we purchase one 30 foot flag pole with lighting in proposed Veterans Memorial Park, Northwest of City Hall and to purchase and properly display a 6x10 foot United States Flag and a 4x6 foot POW-MIA flag at a cost not to exceed \$2000.00 and with the understanding that in approximately 3 years, 5 additional flag poles with flags representing the branches of the military will be installed upon the approval of the Council and also with the understanding that all plans must meet with the approval of the Planning Commission. Carried, all aye.
